## Context and background

The main territorial challenge is to **accelerate the implementation of EU Directives 2010/31/EU and 2012/27/EU** regarding the existing stock of Mediterranean public buildings, given the specific conditions and difficulties related to EEB projects in the MED area and the **associated potential of energy saving**.



MARIE MED strategic project has already produced several outputs to facilitate energy renovation of buildings in the Mediterranean context, and is the useful background to concrete actions.

**The SHERPA project is the logical extension of the MARIE project, inheriting its assets and developing its master lines.**

## Objectives

- The project main objective is to **reinforce the capacities of Public Administrations** at regional and sub-regional level to **improve Energy Efficiency** in public buildings.

The main planned results will be:

- **Generate EEB projects :**
  - 25% energy and 25% CO2 emissions reduction
  - 300M€ invested
  - 100 buildings renovated in the 8 partner reg
- **Involve 50 regions and 500 municipalities** aware of SHERPA transference.
- **Prepare 140 EEB** regional and local (SEAP) **policy agreements**
  - 100 buildings in developed EEB project
  - Local & regional public Administrations buildings
- To test and implement a holistic, transnational and peer-to-peer approach based on 4 key performance elements in EEB strategies: governance; information; awareness and training; and financing.
- To transfer and capitalize the above approach implementing it in the SHERPA regions, strengthening the link between sustainable energy strategies at the regional and the local (SEAPs) level
